REGULAR MEETING OF THE BOARD OF PARK COMMISSIONERS ANDERSON PARK DISTRICT

May 9, 2017

Rob Herking, President, called the regular meeting of the Board of Park Commissioners of the Anderson Park District ("APD") to order at 6:30 p.m. at Park District Headquarters, 8249 Clough Pike, Cincinnati, OH 45244. Present were Board Members: Angie Stocker, Tom Turchiano, and Colin Ramsey. Dominic Wolfer was unable to attend due to a work obligation.

Also present were: Ken Kushner, Executive Director; Emily Armstrong, Board Clerk; Brian Jordan, Financial Officer; and Sheila Fehn, Office Manager.

GUESTS: No guests were present.

PLEDGE OF ALLEGIANCE

OATH OF OFFICE: Angie Stocker read her Oath of Office, as witnessed by Brian Jordan and notarized by Emily Armstrong. The three-year term for Mrs. Stocker commences on the second Monday in May, succeeding her appointment, and expires in May of 2020.

Board Member Public Records Law Training: Mr. Kushner said the Auditor of State requires each Board member receive three hours of Public Records Law training for each term of office. The training is designed to enhance the elected/appointed officials' knowledge of the duty to provide access to public records. The law allows a designee to be appointed on the Board's behalf. The Board previously appointed Mr. Jordan as the designee. The appointment is due to be renewed this year. Mr. Jordan was recently re-certified for the three-hour Public Records Law training course at the Local Government Officials' Conference in Columbus, Ohio on April 11, 2017. The APD is required to have documentation of the designation. Mr. Kushner requested the Board formally re-appoint Brian Jordan to be the designee to receive the public records law training on behalf of the Board. He further welcomed the Board members to attend the training should their schedules allow.

Mr. Ramsey moved the Board appoint Mr. Jordan as the designee to receive the Auditor of State's Public Records Law Training on the Board's behalf.
